LSCB Training

East Sussex County Council, in partnership with Brighton & Hove City Council, have set out a vision for future specialist service which will provide community based interventions for victim/survivors of domestic violence & abuse and rape, sexual violence & abuse.

By jointly commissioning specialist interventions the aim is to bring together a range of existing services, creating simplified care pathways and reducing duplication. This is essential to meet the risk posed to, and needs of, victim/survivors and their families in the context of increasing demand.

In January an Invitation to Tender (ITT) was published, as the first stage of the joint commission, with the process due to conclude in October 2015. Further information on the invitation to tender is available at:

The joint commission is part of the developing approach to commissioning and strategy which is bringing linked areas of work between the East Sussex Safer Communities Partnership and the Safe in the City Partnership together. Other features of this approach are:

A Joint Lead Commissioner, with responsibility for commissioning arrangements and strategic leadership

A Joint Strategy and Partnership Officer, who will support the lead Commissioner.

Operation Ribbon

Police stepped up patrols to combat domestic abuse over Christmas

Police in Sussex provided a pre-Christmas surprise to more than 40 people who have records for repeated domestic abuse of partners.

They all received visits from officers in plain clothes, working with Independent Domestic Violence Advisers (IDVAs), and were told that during the holiday period police would be paying particular attention to any incidents reported as involving them, and would take robust action wherever possible, including arrest, issue of Domestic Violence Protection Notices (DVPOs), and recall to prison.

They were also be given contact details for a charity that specialises in advising perpetrators.

Meanwhile officers and IDVAs visited more than 150 people who have been repeat victims, or who had been reluctant to engage with police following incidents.

From Friday 19 December dedicated patrols responded to reports of domestic abuse over the Christmas and New Year period, with officers equipped with body-worn video cameras to help secure vital evidence, as part of the force's year-round campaign to encourage reporting of such incidents.

Officers continue to respond to and deal with such calls the year round and the force, working with partners, also prioritises the issue through the ongoing **Talk To Us** campaign which encourages the reporting of domestic abuse.

Sussex Police is also working closely with Surrey Police and significant steps have been taken to develop a collaborative approach in tackling domestic abuse. A domestic abuse task force is utilising officers from both forces and was established following the publication of the HMIC report. The intention is to deliver improvements, combine knowledge and experience and deliver economies of scale where possible. This has included the development of our training programme and implementing new domestic abuse legislation, such as Claire's law and Domestic Violence Protection Orders (DVPOs).

Sussex Police was the first police force in England to be awarded White Ribbon status in recognition of the work being done to tackle domestic abuse and is committed to supporting the aims of the White Ribbon Campaign.

CRI's Community Independent Domestic Violence

Advisors Service (IDVAs) provides practical and emotional support to women and men and the service also offers a specialist therapeutic service for children and young people.

“We help victims find out what their options are, including housing, safety and legal issues, and guidance through the court process. We also put them in touch with other organisations that may be able to address their concerns, including refuge accommodation and sanctuary schemes. Our aim is to support people in making informed choices.”

The service provides one-to-one support and individual risk and needs assessments to enable medium and high risk victims of domestic abuse to find the best support for their circumstances. CRI operates safeguarding policies, which are implemented where a person and/or their dependants are thought to be at high risk of continued abuse and further violence. This includes a referral to statutory services and a Multi Agency Risk Assessment Conference (MARAC), to discuss the best possible action for their circumstances and concerns.

Domestic abuse can describe a range of behaviours used by one person to control and dominate another person with whom they have had, or are in a close, intimate or family relationship. It may include abuse of men or women by their partner or ex-partners (including same sex relationships) or one family member to another.

“We will not pressurise clients to take action but guide them through the process, enabling them to make an informed choice. They may first want to talk things through with someone who is unbiased and who will not make judgements. Should they want to pursue a prosecution, we can support them to report the incident as well as explain the court process and arrange a pre-court visit”

What is the WiSE Project?

The WiSE Project is a young people's sexual exploitation project working with and supporting young people up to the age of 25 who are at risk of or experiencing sexual exploitation.

How will WiSE support the young person?

"At WiSE we believe that where a positive relationship already exists between a young person and a worker it is usually most appropriate for WiSE to support that worker in delivering work around sexual exploitation and relationships, rather than taking on a case ourselves. Where a young person has no such relationship with a worker and would benefit from specialist support from WiSE we may offer one to one work. We can meet with a young person to come up with a plan for the work, incorporating their own wishes for support with those from referring agencies and WiSE".

"Please be aware that this sort of work takes time. It can only be effective when the young person has built up a relationship with the worker and begins to trust them. Sexual exploitation sits within the broader context of relationships, family, self esteem, body image, assertiveness, rights & responsibilities, and can affect housing, substance use, offending behaviour, mental health, amongst other needs. The work that we undertake at WiSE might involve supporting the young person with some of these other things before approaching the issue of sexual exploitation. We want to work to build on the young person's protective factors and behaviours in order to minimise their vulnerability and risks of being sexually exploited. WiSE also works closely with a number of other agencies and services and it may be most appropriate to refer the young person elsewhere for the support they need".

Engagement with the WiSE Project is voluntary; professionals cannot include WiSE as a compulsory part of a young person's contract, order or conditional agreement.

Consent Awareness Activities As touched upon in the last newsletter, work has continued with Sussex Police around the issue of alcohol and consent to sexual activity. Some of the rationale behind this work includes:

- There were 89 cases of Serious Sexual Offences in the first quarter of 2014/15 across East Sussex
- 28% of recorded Serious Sexual Offences have involved the offender or victim being under the influence of alcohol
- The Sexual Assault Referral Centre (SARC) activity report for Sussex shows that between 1st April 2013- 31st March 2014, 26% of all referrals were in relation to clients who live in East Sussex. The highest number of referrals were for those within the 18-24 year olds brackets. Just under half of all attendants disclosed having consumed alcohol.

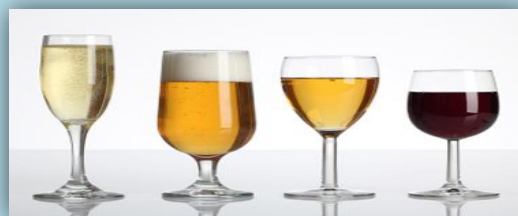
Whilst it would be positive to see a reduction in offences, it is important that people still feel able to come forward and report incidents

The Safer East Sussex Team are grateful to Sussex Downs College for enabling us to carry out 4 consultation events from which we received over 100 completed questionnaire's and had a lot of interesting conversations with young people around this topic. Some headlines from this are:

84% had experienced some form of unwanted sexual incidents

1 in 4 students felt that rape was committed by strangers; However the SARC report states '65% of clients presenting to SARC this year (2013/14) knew, or were familiar with the assailant'

86% agreed that capacity to give consent can be reduced if under the influence of alcohol

Further awareness sessions have also been completed with year 10 pupils at William Parker School in Hastings, and we are delivering the message to year 11 students at the end of the month.

Sgt. Vokins who leads the Sussex Police East Sussex Alcohol Reduction Team revised a personal safety campaign which included the issue of consent, and this was delivered to those working in the night time economy to encourage everyone to look out for those enjoying a night out.

Moving forward we hope to ensure that the topic of consent is understood and delivered to as many people as possible, and work is being done with PSHE (personal, social and health education) leads, Children's Services and Sussex Police to ensure this takes place. There has been a general upward trend in Serious



Sexual Offences where the offender or victim is marked 'under the influence of alcohol' over the past two years.

East Sussex County Council Commitment to the White Ribbon Campaign

ESCC supported White Ribbon Day on 25 November. The day is officially recognised by the United Nations as an international day for the elimination of violence against women.

Every year three million women and girls in the UK experience

rape, domestic abuse, forced marriage, stalking, sexual exploitation, trafficking, female genital mutilation (FGM) or honour crimes.

To show support as a Council against this abuse, ESCC have gained The White Ribbon Campaign (WRC) award. The award is for organisations demonstrating their commitment to the following aims of the campaign:

- *Involving men so that the message increases in effectiveness and reach.*
- *Addressing and changing social norms that lead to violent behaviour against women.*
- *Increasing awareness on the issue and providing services aimed at reducing the incidence of domestic abuse.*
- Mobilising the entire local community under the goal of ending violence against women and girls. As a part of the campaign is for male leaders to take an active stand as Ambassadors and to act as positive role models to their local communities, the male members of CMT (Philip Baker, Kevin Foster, Rupert Clubb, Keith Hinkley and Stuart Gallimore) will be applying to become Ambassadors, with Becky Shaw, our Chief Executive, championing the campaign.

The East Sussex Safer Communities Partnership hosted a half day '**Domestic Abuse Hurts Everyone**' conference on Tuesday, 25 November (White Ribbon Day), with a focus on the impact of domestic abuse on children and young people, what we can do as employers to support employees affected by domestic abuse and raising awareness of the White Ribbon Campaign. The morning was comprised of a host of speakers such as the bestselling author Peter James as well as a highly acclaimed performance entitled 'Mockingbird High'.
